While shifting the base, GERC has frozen FPPPA at 12 Paise up to Dec-06 and thereafter incremental FPPPA is applicable in addition to above 12 Paise/ unit. Hence, 12 Paise / Unit is levible on and above calculated FPPPA for the quarter. Accordingly, FPPPA recoverable w.e.f. 1st April 2009 is Rs. 0.99 / Unit (0.87+0.12). However, it is continued to recover Rs. 0.91 / Unit.
